Dee Development Engineers Limited Corporate Social Responsibility Policy

(Pursuant to Section 135 of the Companies Act 2013)

I. PREAMBLE

The concept of Corporate Social Responsibility has gained prominence from all avenues. Organizations have realized that Govt. alone will not be able to get success in its endeavor to uplift the downtrodden of Society. As a regulatory measure Govt. of India came out with a provision in Company law, requiring certain companies to spend a portion of their profit for social good. For DEE Development Engineers Limited (hereinafter referred as "DDEL") in the present context, CSR means not only investment of funds for Social Activity but also involvement of the Company's with Social processes. DDEL, since its inception, was aware of its Corporate Social Responsibility and was fulfilling the aspiration of the Society by extending its hand for social good. This has resulted into a harmonious relationship between DDEL and the peripheral Communities.

II. INTRODUCTION:

The units of DDEL are located in Haryana, Punjab & Tamilnadu. The impacts of the introduction of any production activity in such areas change the indigenous communities and also change the socio-economic profile of the Area. Hence, the primary beneficiaries of CSR should the poor and needy section of the society living in different parts of India. In the aforesaid backdrop, policy on Corporate Social Responsibility of DDEL is broadly framed taking into account the following measures:

- b) Contribution to the society at large by way of social and cultural development, imparting education, training and social awareness especially with regard to the economically backward class for their development and generation of income to avoid any pressure on job, rather to create jobs.

OBJECTIVE

The main objective of CSR policy is to lay down guidelines for DDEL to make CSR a key business process for sustainable development for the Society. It aims at supplementing the role of the Government in enhancing the welfare measures of the society based on the immediate and long term social and environmental consequences of their activities. DDEL will act as a good Corporate Citizen, subscribing to the principles of integrating economic, environmental and social objectives with the company's operations and growth.

III. STRATEGY FOR AREAS TO BE COVERED

With a view to make DDEL CSR Policy sustainable, its activities will be based on Core Competency, Community and Business Associates having multi stake-holders approach adding value to the bottom line and also execute CSR objectives on the ideals of social justice without discrimination.

As a CSR process, DDEL will make identification of projects with long term, medium term and short-term action plans matching with the business plan based upon the following –

- Counseling of parents
- Special attention on education, training and rehabilitation of mentally & physically challenged children/persons.
- Promotion of Professional Education by setting up educational institutions offering courses in ITI, Engineering, Nursing, Management, Medicine and in Technical subjects etc.

iii. promoting gender equality and empowering women;
